How do I prepare a container inspection checklist?

Maintain a copy of the 8 point container inspection checklist with the plant's daily paperwork. Submit the 8 point container inspection checklist with the shipping documents. Maintain a copy of the 8 Point Container Inspection Checklist with plant's daily shipping paperwork. Inspect prior to entering facility. Support beams should be visible.

Do electric energy storage systems need to be tested?

It is recognized that electric energy storage equipment or systems can be a single device providing all required functions or an assembly of components, each having limited functions. Components having limited functions shall be tested for those functions in accordance with this standard.

Can CSRS be applied to energy storage systems?

Until existing model codes and standards are updated or new ones are developed and then adopted, one seeking to deploy energy storage technologies or needing to verify the safety of an installation may be challenged in trying to apply currently implemented CSRs to an energy storage system (ESS).

How do you know if a container is tampering?

The door, handles, rods, hasps, rivets, brackets, and all other parts of a container's locking mechanism must be fully inspected to detect tampering and any hardware inconsistencies prior to the attachment of any sealing device. Look for unusual repairs to structural beams. Repairs to walls on the inside must be visible on the outside.
