What is the difference between harmonised system and Customs Tariff Nomenclature?

Whereas the Harmonized System is (in economic terms) a neutral classification tool (no relation with rates of import duty), a Customs tariff nomenclature is an economic or even a political instrument, by the inclusion of rates of import duty.

What is the HS code for batteries?

The HS Code for batteries is typically 8507. It is used to classify batteries and other accumulators in terms of their voltage and energy storage capacity. What is the classification for storage devices under HS Code? Storage devices are classified under different HS Codes depending on their specific type and function.

Commodity codes are internationally recognised reference numbers. A code describes a specific product when importing or exporting goods. You will use this code on any import declaration and can find them in the Trade Tariff tool. You'll need to find the right commodity code for any goods you import or export, as it works out:

What is the HS code for storage devices?

The specific HS Code for storage devices depends on factors such as the type of device, its power capacity, and application. In general, storage devices like accumulators and batteries are classified under HS Code 8507. This code covers electrical accumulators, including rechargeable batteries, and other devices used to store electrical energy.

What is a power unit HS code?

The power unit HS code plays a crucial role in the classification and regulation of power storage devices, such as accumulators and batteries. The HS code, also known as the Harmonized System Code, is an international standard used for the identification and classification of various products traded across borders.

The tariff classification code is directly linked to the rate of duty payable on that commodity. Classification operates as part of the international Harmonised Commodity and Coding System, under the WCO Harmonised System Convention. Tariff classification of goods is one of the more complex issues under the Customs and Excise Act.
