How should battery energy storage system specifications be based on technical specifications?

Battery energy storage system specifications should be based on technical specification as stated in the manufacturer documentation. How much energy storage capacity does the EU need?

While many requirements in the IFC and NEC reference NFPA 855, not all its provisions are explicitly stated within the fire code.
