Are solar PV panels part of the Green Homes Grant Scheme?

Solar PV panels are not currently part of the Green Homes Grant Scheme in England. However, you can apply for a grant to put towards a solar thermal panel system instead, which uses solar energy from the sun to generate hot water for a property.

Are there any government grants for solar panels?

The only active government grants for solar panels is ECO4. 'ECO4 is the latest phase of the Government's Energy Company Obligation scheme that's designed to help low-income families to save energy, make homes warmer and reduce carbon emissions', explains Nathan, Rated People.

Can you get a grant for solar panels in the UK?

This applies to every country in the UK except Northern Ireland. From April 2023 to March 2025, 45 local authorities in England can give grants of up to £10,000 to homeowners in their area for improvements including solar panels. These grants are also available for insulation, heat pumps, double glazing, solar thermal and heating controls.

What if I don't qualify for a solar panel grant?

Do I need a grant to install solar panels?

You must also apply for and receive a grant offer from SEAI before buying any solar panels and starting any installation work. There are also grants for solar PV installations for businesses including public buildings, sports clubs and community organisations available through SEAI.

What is a solar electricity grant?

The Solar Electricity Grant administered by the Sustainable Energy Authority of Ireland (SEAI) provides one-off grants towards the purchase and installation of solar panels for homes. To qualify you must:
• Be the owner of a home built and occupied before 2021
• Use new materials and products that were not already covered under another grant scheme
