The customer pays a fee for his subscription according to the grid tariff's capacity fee. The capacity fee shall cover the costs of operation, maintenance and utilisation of the network. The customer also pays a usage fee, to cover the cost of buying electricity losses in the network. The usage agreement is signed annually.

Energinet's activities are financed through tariffs. A tariff is a charge that consumers, producers and balance agents pay. Energinet's transmission tariffs and fees cover the costs of operation, depreciation, financing and administration.
