How to ensure the quality of solar panels during production inspection?

One effective method is to conduct a during-production inspection. This quality check thoroughly inspects each panel's materials, manufacturing process, and performance characteristics to ensure they meet the required standards. Ensuring the quality of solar panels during production inspection is important for multiple reasons:

What if a solar PV module sample is rejected?

A solar PV module sample will be considered to be rejected due to its observable quality defects if any one of the following conditions are met: If any single observed defect has been evaluated as a Severity of 5. A Severity of 5 indicates a major quality issue; a critical failure or a fraudulent module.

How to reduce the cost of photovoltaic systems?

One key factor of reducing the costs of photovoltaic systems is to increase the reliability and the service life time of the PV modules. Today's statistics show degradation rates of the rated power for crystalline silicon PV modules of 0.8%/year [Jordan11].

What is a severe rating on a solar PV module?

The schematics in the Terminology section describe where each component is found on a common solar PV module. A Severity Rating is also defined to give users guidelines on how concerning a particular defect may be.

How do you know if a photovoltaic module is bad?

Where cells have become shiny or changed colour locally, cells have a poor or degrading anti-reflective coating which is an indicator of poor module performance. What impact do the standards have on the PV industry?

These standards have limited impact on the PV industry, where the use of plastic is low and the content of REEs in PV modules is almost non-existent (although the dependence is higher in electronic equipment of BoS).

Although the standard gives the possibility to perform the test for a range of cell temperatures (25 °C to 50 °C) and irradiance levels (700 W/m² to 1,100 W/m²), it is common practice among PV laboratories to perform it at the so-called Standard Test Conditions (STC). By definition, STC corresponds to: 1000 W/m², 25 °C;

Under typical UK conditions, 1m² of PV panel will produce around 100kWh electricity per year, so it would take around 2.5 years to "pay back" the energy cost of the panel. PV panels have an expected life of least 25 to 30 years, so even under UK conditions a PV panel will generate many times more energy than was needed to manufacture it.

Basically, certifications per se do not tell much about the quality of a module. If you buy a solar module with IEC 61215/ 61730/ 61701 etc. certifications, it means that the certification-holding manufacturer managed to produce a few modules of that type that passed a standard's (e.g. IEC 61215) tests at the time of applying for certification.
