Do you pay VAT on solar panels?

Homeowners will pay 0% VAT on solar panels and other energy-saving materials until April 2027, compared to 5-20% previously. Though there are a few exceptions. For example, you will need to use the same provider to supply and install solar panels to qualify for 0% VAT.

Are solar panels VAT free in the UK?

Since April 2022, UK homes have been able to benefit from zero VAT on solar panel materials and installation. The scheme ends in March 2027 and returns to 5% VAT. While it's at 0%, the average family can save more than £1,000 when choosing to have solar panels installed and up to a further £1,180 a year on energy bills.

Will new solar homes get a payment from suppliers?
