

Are all solar PV generating assets subject to business rates?

1. Are all solar PV subject to business rates? Non-domestic solar PV generating assets are rateable, however the Business Rates applied can vary considerably on the circumstances of its use: whether the site is set up as for 'mainly export' or 'mainly self-consumption'. The test applied is whether more than 50% of the power produced is exported.

What is 0% VAT on solar panels?

The 0% VAT on solar panels in the UK is a temporary measure, set to last until 31 March 2027. From 1 April 2027 onwards, the VAT rate on solar panel supplies will go back to the reduced rate of 5%, in line with the UK government's financial and renewable energy goals. Does 0% VAT apply to solar batteries?

Are solar panels tax deductible in the UK?

According to the UK government's list of Energy Saving Measures (ESMs), most solar photovoltaic (PV) panels installed on residential properties in Scotland, England and Wales (plus Northern Ireland, as of 1 May 2023) are exempt from VAT, meaning there's no VAT included in the purchase and installation costs.

How is a solar PV asset rateable?

If assessed with the host site as on-site consumption, the solar PV asset becomes rateable according to what is known as the Contractors Basis. How are Rateable Values calculated?

Is there VAT on solar panels in the UK?

Since there's no VAT on solar panels in the UK, it's more affordable for homeowners to get solar PV systems installed. For example, a 3.5 kilowatt peak (kWp) solar and battery system for a typical three-bedroom home currently costs around £9,000, and that already includes the benefit of the 0% VAT rate.
