Are there government grants for solar panels?

There are no government grants for solar panels. There are no free solar panels on offer. However, you can take advantage of the Smart Export Guarantee. To conclude, you could save as much as £744 a year for the average-sized home (that's the £514 from the energy generation itself and £230 in SEG revenues you'll generate for the year).

Can you get a loan for solar panels in Scotland?

However, a loan of up to £5,000 is available for solar thermal panels and hybrid solar PV/water heating. To improve insulation in homes with low energy ratings and combat high energy bills, the Scottish Government has launched a series of grants and loans under Warmer Homes Scotland.

What does a solar panel grant cover?

Solar grants often only cover specific solar energy system components such as solar panels, inverters and installation costs. Battery storage or advanced monitoring systems are typically excluded from these funding programmes. How much can I save with a solar panel grant?

The average home can save more than £1,100 every year with solar panels! There are several solar panel grants and incentives currently available in the UK, aimed at reducing the cost of solar panels, your households' energy bills and encouraging the adoption of renewable energy. Can you get a solar energy grant in 2023?

The grant opened in April 2023 and will run until March 2025. It can be used to fund home improvements, such as insulation, heat pumps, double glazing, solar thermal, and solar PV panels. As of February 2024, 28% of the grants handed out have been for solar panels, so applying for the grant is worth a shot if you're eligible.

A solar battery can store any excess power generated by your solar panels that you don't use at the time, rather than exporting it back to the grid. They can cost as little as £1,000 for a three kilowatt-hour battery. The Eco Experts estimate the average price to be around £4,500.

The loan is completely interest-free and is repayable over a five-year period (if you borrow less than £5,000) or 10 years (if you borrow £5,000 or more). All residents of Scotland can apply for the funding.
