



Solar power rebate scam

What is a solar energy scam?

The scams vary, but here's the gist: someone claiming to be with the government or your utility company promises big savings on your utility bills from solar energy or other home improvements designed to increase energy efficiency. If you agree to the scammer's offer, it could cost you tens of thousands of dollars.

Are free solar panels a scam?

Know that "free" or "no cost" solar panel offers are scams. The federal government does not install solar systems in homes for free. If you're considering whether solar energy is right for you, check out the Department of Energy's guide for homeowners and learn more. Or check out the Department of Treasury's guidance on clean energy.

Are solar rebates a good idea?

Legitimate companies will usually share the benefits of going solar (of which there are many!) without promising specific, guaranteed amounts. However, rebates and referral bonuses are common and legitimate ways solar installers and other companies may lower your system's cost.

Are 'fake' solar companies a scam?

Beware of any company asking you to make a big deposit before they have completed their installation. This is one of the most common ways 'fake' solar companies have targeted consumers - whereby they take a hefty deposit and then never turn up to carry out the installation. This is common solar scam.

How did scammers use the £400 government energy bill rebate?

Scammers used the £400 government energy bill rebate, known as the Energy Bills Support Scheme, to trick people into handing over their details. This scheme ended for most households in March 2023, and payments would have come directly from your electricity supplier.

What are energy scams?

Energy scams involve people pretending to be energy companies or regulators to get your money or personal information. These scammers may pretend to be your energy company, say they're from Ofgem or even from Energy Saving Trust to try and gain your trust.

The scam emails pretend to be from the energy regulator Ofgem and are headed "Claim your bill rebate now", telling recipients they are due a payment under a government ...

South Australia solar rebates. In the City of Adelaide, there's a Sustainability Incentives Scheme that provides rebates for solar power systems for concession card holders and landlords with a property in the City of Adelaide. There are also rebates available for shared solar systems for tenants of multi-storey buildings, up to \$500 per premises.

Scammers posing as government representatives are calling consumers and offering rebates for installing energy efficient appliances, solar panels, water tanks, new insulation and the like. The scammer will ask for bank account details or for a fee to be paid before the rebate can be processed. Unfortunately, these promised rebates never appear.

In one such scam referenced in the AP story, a Facebook page called "Solar Energy Today" promised solar energy tax credits - which didn't exist - or rebates if homeowners installed new solar panels. The ads featured pictures of various governors to localize the content, based on where the user lived.

Another day, another scam. Solar and heat pump buyers across Australia are being warned of a new scam that is seeing many Aussies left with low-quality products and poor installations. While scams in the solar industry are as new as sliced bread, this new con is now leaving reputable installers in the lurch, too.

The con works like this - you receive a phone call or house visit, and get fed stories about free solar panels or huge rebates that will pay for your entire installation. The only catch is they require an upfront payment. They rush you into the decision by saying there is only a limited time or a certain number of households that can cash in.

One homeowner was approached by a door-to-door salesperson "claiming he could get me a new roof plus solar equipment, with a government rebate for 26% off cost, essentially paying for the new roof."
